During the term of the lease the Lessee shall be responsible to provide animal husbandry that will maintain the nutritional, mental and physical health of the horse including, but not limited to, parasite control, hoof trimming, vaccinations, shelter, etc. Further, if the horse is injured or seriously ill the Lessee shall immediately inform the Lessor.

The Lessee shall be responsible to provide any and all applicable forms including, but not limited to, Stallion Reports, Breeder Certificates, etc., that are required from time to time pursuant to the terms and conditions of the ApHCC Constitution, By-Laws, Regulations and Rules.

The Lessor hereby grants and the Lessee hereby accepts possession of the horse upon the above conditions and further consideration as described:
